DATES: 22 Oct, 26 Nov, 2017 & 28 JAN, 25 FEB, 25 MAR, 2018
LOCATION: Cincinnati Revolver Club Range 4951 Winton Ridge Ln. Corner of Kings Run Rd. Use exit #6 from Interstate 75 (Mitchell Ave. - St. Bernard Exit) see map.

RULES: Current NRA Precision Pistol Rules shall govern.

CLASSIFICATION: NRA classification will be used. Unclassified new shooters may choose to enter match 10 only at a reduced fee in order to obtain a temporary classification. Temporary score books will be used after the first firing date.

ENTRIES: This is an open match, NRA membership is not required. Entries will be limited to 42 competitors (2 relays) per firing day.

TEAM ENTRIES: A team will consist of any four firing members representing the same club or organization as defined in NRA rules.

MATCH FEES: NRA Registration fee is \$5.00. Individual match fee is \$2.00 per match. "Shoot the Works" for \$25.00. Team match is 10.00 per four man team. First time unclassified shooter's fee is \$10.00.

STARTING TIME: 9:00 AM, Eastern time.

SQUADDING: All matches will be squadded, each relay will fire the entire 60 shot aggregate before scoring. The .22 Caliber pistol may be fired in all matches for classification only.

SCORING: Competitors will score the target to their left and will be

responsible for signing and returning their score cards to the statistical office.

INDIVIDUAL

AWARDS: Competitors may choose cash, or an equal value in trophy, medal, or NRA points, as follows:

Match 10 Grand Aggregate Winner	\$6.00
Match 10 First in Class	\$4.00
Match 10 Second and below	\$3.00
Match 1-9 Winner	\$4.00
Match 1-9 First in Class	\$3.00
Match 1-9 Second and below	\$2.00

An award will be made to the Winner in each match and first in class in each class of four or more competitors. Additional class awards will be made on the basis of one award for each four competitors. Unclassified shooter will receive an award for two or more competitors entered in Match 10 only.

The winner of each match will be subtracted from his class before computing the number of other awards in that class.

Any class with less than four competitors will be combined with the next higher class.

A Master class of less than four competitors will compete for winner awards only

Trophies or medals will be awarded only to competitors winning two or more awards. Trophy winners will have their awards combined into a single trophy.

Second of five or more teams	\$5.00
