FACILITIES: Lighted firing points with turning targets at 50 feet

MATCH DESCRIPTION: NRA 2-gun 1800 (.22 and CF) match. A separate .22 only 1800 championship will be held concurrently with the State Championship for shooters wishing to do so.

ENTRIES LIMIT: There are only ten spots at each range available per relay. Make sure you email or text Dane Hogle to reserve a spot.

Note: Preference for space available will be given to "Shoot the Works" competitors. Each competitor will fire a complete "900" before leaving the firing line.

Time: Registration begins one half hour before relay start time each day.

Please note: RELAY 1: 9:00am
RELAY 2: Approx. 12 Noon
RELAY 3: Only if Relay 1 & 2 are full

ENTRY FEE: \$47.50 Includes NRA registration fee (\$5.50) for non ORPA members
\$40.00 for OPRA members or competitors from other states. Must belong to that state's organization.
-All ranges receive \$20.00 per competitor for time and materials.

RULES: Current NRA rules shall govern this match. Competitors will score another competitor's targets. During .45 Slow Fire, competitors will change targets after every 5 shots. Challenge fee is \$2.00. If challenge is sustained, fee will be refunded. The plug-type scoring gauge will be restricted to use by the Ranger Officers and the Referee.

CLASSIFICATION: The NRA classification system will be used in all matches. Individuals who have not been classified will fire in the Master Class, Rule 19.6 (Assigned Classifications may be used.) Competitors will not be divided into categories. If there are less than 5 competitors in any other class, the class will be combined with the next higher class. A class will not be combined downward. If there are less than 5 High Masters, they will compete for MATCH WINNER only.
